

Brownsville Officials Soccer Association 6th – General Association Meeting Wednesday, January 22nd, 2020

- I. The sixth meeting was called to order at 7:00 pm by our President Mr. Hector Cardoza. The meeting took place at the Texas Southmost College Recreation Center, 2000 W University Blvd. Hector welcomed all members to the meeting and thanked those who went to the Physical test the past Saturday and encouraged all to go to the next physical test on the 25th of January at 3:00pm at St. Joseph Academy.
- II. Treasurer's Report Mr. Julio Rodriguez presented an updated report of the balance we currently have on the chapter. He mentioned that not all scrimmage fees have been paid by school districts.
- III. Assigning Secretary's Report Mr. Raul Cano mentioned the responsibilities of all 3 assignorst and reminded members that when a game is assigned and the assignor made a mistake, this being game site or date, the assignor will pay \$15 to the referee (Metro fee). This will come out of his/her pocket and not from the chapter. Raul said that tournaments are starting to be paid and asked members to be patient for other tournaments pending to pay. Raul also advised that there will be a training at the next meeting if possible, for members with 3 years of experience or less for the duties and mechanics of assistant referees. He was going to collect fees at the end of the meeting

- V. President's Report Mr. Cardoza asked all members interested in officiating regionals and state to please send him an email so he can include them in the list and send it to TASO/UIL. He went over all the situations that need a UIL Incident report to be submitted. Finally, he explained what he and Mr. Cano talked about with the Athletic Director of BISD in a meeting they had the previous week. The talk focused mostly on the game administrator's and security guards' duties.
- VI. Secretary report Mr. Sosa went over the last meeting minutes. All members agreed that it would be better if meeting minutes are sent before each meeting to just vote and save time for instruction/trainings. He also went over how to fill the BISD direct deposit form and asked members who were interested in filling it out to let him know so he can send it via email. Last, he went over the uniform expectations for games.

VII. Training

a. Mr. Hector Cardoza reviewed the difference between Illegal and Improper equipment. He also mentioned the rulings and procedures when any of the incident arises.

- b. Mr. Edder Yepez provided training for all members for Rule 9: Ball In & Ball Out of Play. He reviewed each situation, the correct procedures, rulings, and mechanics.
- c. Mr. Arturo Ibarra provided training for Rule 15: Throw-In. He gave several examples about what a good throw in is. Both feet on the ground, not crossing the sideline with one or both feet, and delivering the ball from behind and over the head in one continuous movement.

VIII. Floor became open for members opinions and comments

a. Mr. Arturo Ibarra proposed that the chapter buys all members Nike V-neck dri-fit shirts with Screen print of the BOSA logo. He presented a quote for the Screen Printing. Motion passed by majority.

IX. Adjournment

a. Motion to adjourn was proposed by Mr. Juan Gandara Jr. and seconded by Mr. Raul Cano. Meeting was adjourned at 8:46 pm.
