 - a. BOSA By-laws (President Resignation Process): If a vacancy should occur in the Presidency, the Vice-President will assume the duties of the President for the unexpired term.
- 3. Vice President:
 - a. BOSA By-laws (Vice President Process)
 - If a vacancy should occur in any other office, it will be announced by email and nominations may be submitted during the next meeting. The vacancy will be filled by a majority of the eligible voters present on the next meeting after the nominations meeting. No person may simultaneously hold more than one position in the Board.

 - iii. \$20: Returning officials who did 7 scrimmages last year, but register on TASO on or after Sept. 1
 - \$10: Returning officials who did 7 scrimmages last year and register on TASO before or on Aug 31
