- III. Secretary
 - a. Uniforms:
 - i. EVERY OFFICIAL Effective immediately you MUST have 5 PRO long sleeves shirts (Red, Green, Blue, Black & Yellow), USSF shorts and 3 line socks as per request of several officials
 ii. Still members with OLD UNIFORMS, WILL BE FINE \$50
- IV. Treasurer's Report
 - a. Local Fees \$40 (if you have referee communication head set, \$10)
 - b. Scrimmage Pay Sheet in order for every Referee to get credit for scrimmage games done, referees must submit Scrimmage Pay Sheet (collect at end of meeting)
- V. Assignor Report

 - b. Average of games as of today is 11 games / Accept or decline games immediately
 - c. Varsity and One Man System Tournaments: using experienced refs with more than 5 years of exp.
 - d. NEW OFFICIALS no paper, no pen, no coin, no cards
 - e. Game accepted and inform us that you cannot make it will be a \$15 fine / a game that has been assign to you (no game due to MISTAKE of assignor) will result in \$15 to you
- VI. Vice President Report
 - a. Scrimmage Games: December 12 January 1
 - i. A total of 149 games were covered
 - ii. Each member had to do 5 Scrimmage games; failure to do so was a \$50 fine (only 1 official did one game, he/she will be fine \$40)

VII. Soccer Rules that **DID NOT CHANGE:**

- a. Ball has to completely leave Penalty Area on a Goal Kick in order for the ball to be in play.
- b. If the ball hits the referee, game continues as normal (we don't stop play).
- VIII. Soccer Rules that CHANGE:
 - a. Stop the clock during the last 5 minutes of the second half or overtime half **ONLY** if the team in the lead substitutes.
 - b. Drop ball: following temporary suspension of play for an injury or unusual situation AND a goalkeeper is not in possession of the ball (*no more Indirect Free Kick to a team in clear possession*). Any number of players may contest a dropped ball, including goalkeeper.

Note: If a dropped ball enters the goal without touching at least two players, play is restarted with a goal kick if it enters the opponent's goal or a corner kick if it enters the team's own goal.
